1998-99

1. Name of Society : The name of the society is and shall be "Sadbhavna Society" here in after referred to as "Society".
2. Registered Office : The registered office of the society shall remain, and at present is at the following address :-  
Ludhiana Road, Raikot 141 109 Distt. Ludhiana, Punjab.
3. Polley : The Society will work for the ultimate policy of "Rural Development in Health and Education sectors." It will work to make the various social welfare measures reach the rural remote and underprivileged population. The Society will also work for the promotion, development and popularization of Bengali language and culture in the local community (Punjab) and to augment Punjab - Bengal cultural relationship. involving the linguistic minority (Bengali) population.

4. Objectives : The aims and objectives for which the society will endeavor are here in under :-

- a) To spread the light or education and health. to all doorsteps, particularly the rural remote underprivileged population and the disadvantaged groups, by commencing new educational institution, opening vocational training centres, generating more employment potential, promoting social awareness campaigns for health and disease (like AIDS, addiction, Cancer, Bubererculosis etc.) and by organizing Community Training Camps to combat socio-medical pathologies (like AIDS, addition etc.) and other such social welfare activities/programs.
- b) To develop the health and education standard of the community by inculcating better understanding, positive attitude, scientific knowledge and rational thinking, particularly in the rural remote and underprivileged population.
- c) To conduct training in various fields of medicine. To educate the community on socio-medical obligations. To promote awareness about health and disease amongst the masses. To elevate the social, socio-medial and socio-economic standard of the society, thus resulting in rural development.
- d) To conduct basic and applied research in all fields, systems and disciplines of medical science and health care, to provide research facilities, to open or take over medical health care, to provide research facilities, to open or take over medical health care institutes for research and development of branches of medical science.
- e) To promote education - formal and non-formal - particularly for empowerment of women. To promote various types of vocational training to encourage self-employment. To generate more job potential by commencing job-oriented courses, particularly in health sciences. To establish / take over educational institutes / programs.
- f) To promote primary health care - primary prevention and early detection of disease. To augment community consciousness about health, disease, prevention early diagnosis, treatment modalities and rehabilitation.

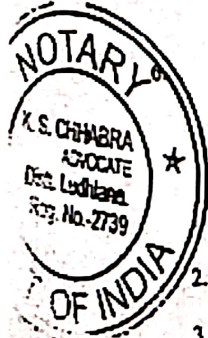

- g) To conduct social surveys and field studies in all fields of health and education to collect a broad-base statistical data. To carry out research and development of preventive and social medicine on this database.
- h) To provide, encourage, initiate or promote facilities for discovery, development or improvement of new methods of prevention, diagnosis, treatment, rehabilitation or understanding of disease.
- i) To develop, spread and popularize Bengali language and culture in Punjab, to establish elementary educational institutes for learning / teaching Bengali Language and culture in the local community.

5. Application of Income : The income and properties of the society, where so ever derived, shall be applied solely to the fulfillment of the objectives of the society. Nor portion there of shall be paid to or divided amongst any of its member by way of profits or dividends. Provided that nothing contained shall prevent the payment in good faith of remuneration to its office bearers, volunteers, servants, workers or other employees or to any member of the society or to any person in return of any service rendered to the society. Nor it shall prevent application of income full or part towards payment of purchase money, administrative expenses, interest, insurances, repairs to the premises and other properties and also for running the business and affairs of the society to attain any of its objectives. Any surplus income left in the hands of the governing committee members shall be deposited, invested or lended to individuals, securities, properties or investments, as the members think just and proper in their discretion.

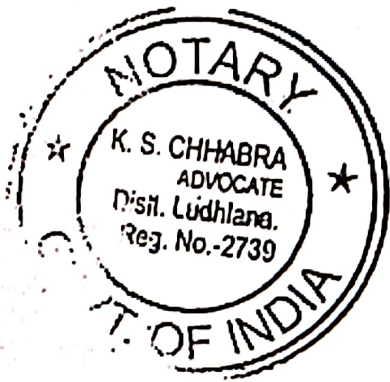
